Active Transportation Plan Update (Oaks) (45 min) -

- Currently in the works:

- Improve pedestrian safety, seating and shelter at bus stops
- 0
- Signage on 40<sup>th</sup> street has already been approved
- Bringing safety, comfort and mobility to all
- Goals:
  - Hoping to engage w/ EUSD on safe routes to school by next spring
  - Inserting joy and Community
  - o Bringing safety, comfort and mobility to all
- Ongoing and Completed Highlights
  - Evaluating opportunities to integrate pedestrian and bike infrastructure into CIP and other active projects
  - Evaluating opportunities for larger pedestrian intervals
  - Evaluating legislation regarding lowering speed limits
    - Successfully Reduced Horton St to 15 MPH
  - New bike headcounter last year
  - Bikes to Wherever had the highest employer participation ever
  - o 100 new bike racks
  - Encouraging safe education routes and making safety improvements on streets
  - o Completed "Quiet Zones" for the railroad in the North
  - Intersection Improvements



## City of Emeryville

- Intersection Improvements
  - 47<sup>th</sup> and Adeline
  - South Bay Front Bridge Intersection
  - Along Shellmound
  - Programmatic Recommendations
    - Measuring sustainability by looking at different aspects like parking meters, transit use, Bike to Workday counts, bike share numbers
    - o Equity: targeted outreach and programs to ensure fair access
    - Pedestrian bike infrastructure
      - Example: disproportionate amount of low-income housing on lower San Pablo Ave where there are no parks (not feasible to add parks due to location). Potential solution is to improve bike & pedestrian infrastructure instead of better parking access
    - Powell St. Pedestrian/Bike path to the Marina
    - Eventually apply for the Bicycle Friendly Community Program (not yet applicable)
    - Add driver education courses (plans to connect with Senior Center about their program)
    - Enforcement
      - Concerned about disproportionate impacts
      - Redirect behavior and improve behavior with giveaways and different/new approach rather than citations
        - Example: Giving someone a bike light rather than a citation for not having one
      - Educate people on the reasons for rules and regulations and explain why they are there when applicable
  - Upcoming Plans:
    - Bike station at Bay St. (2024) with 3 more coming 2025
    - Spooky Streets (Trick or Treating across 4 streets with food trucks, an overall good time)
    - Education safe routes
      - Get the ball rolling in 2026
      - Staffing issue
    - 40<sup>th</sup> St. has been designed, loop is being analyzed for feasibility
  - Committee Feedback
    - Transportation Committee
      - Next year more info on funding
    - o VPAC
      - More data sources to be included next year
      - Assessments of changes in transit numbers

  - Suggested using public health data of injuries to track how things are going in city
- Commission on Aging
  - Giving pedestrians a separate area of focus from cyclists
    - Trip hazards around city (2 major ones by Senior Center)

  - Operational for 8-10 weeks now
  - 1-3 Clients/week coming in with various questions and or concerns, mostly "How do I...?", no health concerns so far
  - Moved from Billiards Room in the Senior Center to a 2<sup>nd</sup> floor office
  - 3 active volunteers with rotating staff on Wednesday to support the volunteers and help train them to work independently
  - Received tremendous support, ex: a lot of marketing and presentation to potential clients
  - Incoming interns from the Social Worker Program at Samuel Merrit to help soon

  - Parks and Rec
    - No meeting this month
  - PAPCO
    - Combination meeting, went over survey with the goal of improving programs next year, not enough responses were received, going to send out letters and have surveys at senior centers to get more feedback
    - Applications for using East Bay Transit are complicated and not as simple as getting an Uber from a user experience perspective
  - Friends of ESC
    - Will sell wine and beer in 21+ section at Harvest Festival to fundraise for the Senior Center
  - Community Services and Senior Center
    - Will have a table at the Harvest Festival to promote committees to the public committee members invited to help

- Still working on filling Kim's position, hopefully in place by next meeting
