Subject: Item 5.1 - Blue Curb Request at 4515 Hubbard Street

BACKGROUND:

The Public Works Department received a request to add an ADA blue disabled parking zone to a portion of the curb along the frontage of 4515 Hubbard Street. The proposal converts one limited duration (green) parking space into blue curbed disabled person parking zone.

Blue Curb Requests

Per the Emeryville Municipal Code (EMC), the Transportation Committee is authorized to designate any part of any City street or publicly controlled off-street parking facility as a disabled person parking zone, with the consent of the City Council.

The EMC 4-9.17(e) identifies Disabled Persons Parking Zones as follows:

- "The Transportation Committee, with the consent of the City Council, is authorized to designate any part of any street or publicly controlled off-street parking facility a disabled persons parking zone. Only operators of vehicles displaying a valid permit or distinguishing license plate issued to disabled persons by the Department of Motor Vehicles shall park in a disabled parking zone. The Department of Public Works shall mark the curbs of disabled parking zones blue, and signs shall be posted to alert the public that only properly authorized disabled persons shall be permitted to park in such locations."
- "It shall be unlawful for an operator to park any vehicle in a disabled parking zone
 unless that vehicle displays a valid permit or distinguishing license plate issued to
 a person with a disability by the Department of Motor Vehicles."

DISCUSSION:

Staff received a blue curb request from Idowu Koyejo, business owner of the TEME Salon, located at 4515 Hubbard Street, Unit #126. The request was to provide one disabled persons parking space on the west side of Hubbard Street, in front of the applicants salon. Any new ADA blue disabled parking zone is not for the private use of the Applicant and

would be available to any person possessing a valid plate or placard from the California DMV.

After investigating the site and the surrounding neighborhood, the parking space immediately in front of the applicants salon is adjacent to a fire hydrant "no parking" zone, and the nearest pedestrian refuge for a wheelchair-bound driver would be approximately 60 feet to the north. Additionally, there does not appear to be any publicly accessible onstreet ADA parking spaces in the neighborhood surrounding the Applicants business/residence.

Staff have reviewed the request recommend installing an approximately twenty-two foot long ADA blue disabled parking zone at the southern end of the building. The recommendation will convert one limited duration parking spot into blue curb, as shown in the following aerial photograph.



RECOMMENDATION:

Staff recommend for the Transportation and Sustainability Committee members to review the Curb Color Exhibit and approve the ADA blue disabled parking zone at 4515 Hubbard Street.

SUBJECT: Item 6.1 Lyft Bay Wheels Information – Usage and Pricing

BACKGROUND:

The Transportation and Sustainability Committee requested information regarding the usage and pricing of the bike share program operating in Emeryville (Bay Wheels). This memo provides a brief overview on system history, Emeryville stations, current pricing, current ridership, and program costs. The presentation that will provided to the Committee at their September 9, 2025 meeting will include more Emeryville-specific information.

PROGRAM HISTORY:

Bike share began as a <u>pilot program in the Bay Area in 2013</u>. The pilot program included San Francisco and four other cities on the Peninsula, and none in the East Bay. The original pricing structure was \$88 for an annual pass, \$22 for a three-day pass and \$9 for a daily pass.

In December 2019, the Bay Area Bike Share Program Agreement between the Metropolitan Transportation Commission (MTC) and Bay Area Motivate, LLC was finalized. The agreement stated that the "bike sharing program will provide a 24-hour transportation network that complements existing transit and transportation options, increases multi-modal travel options in the region and encourages bicycle use as a healthy, environmentally friendly and congestion-reducing transportation option." The exclusive agreement was negotiated for the "design, build, operation, maintenance and marketing of a network of publicly available bicycles in a bike share program in the Participating Cities" of Berkeley, Emeryville, Oakland, San Francisco and San Jose.

The Program agreement includes a fleet of 7,000 – 7,055 bikes operating from a minimum of 500 stations, allocated in the following way:

- 4,500 in San Francisco;
- 1,000 in San Jose;
- 400 in East Bay, with:
- 850 in Oakland,
- 100 in Emeryville, and
- 400 in Berkeley.

The program operator has changed over time. The contract was originally with Bay Area Motivate, LLC, was rebranded as "Ford GoBike" in 2017, and then rebranded to "Bay Wheels" when it was acquired by Lyft in 2019.

In <u>November 2023, MTC and Lyft announced</u> that 2,000 next generation e-bikes and 55 additional docking stations would be added in San Francisco, San Jose, Oakland, Berkeley and Emeryville. Emeryville was allotted three of these additional stations.

The current contract between MTC and Lyft expires and 2027. Both parties are currently working on an agreement to extend the current contract by three years.

EMERYVILLE STATIONS:

Emeryville currently has 12 bikeshare stations:

- In 2017 bike share launched in Emeryville with 10 stations as part of an East Bay expansion at no cost to the City (other than staff time for permit processing, coordination, etc.).
- In 2019 a station was added by the property owner of 2100 Powell Street. This expanded Emeryville's total station count to 11.
- In 2024 a new station was installed by the property owner of Bay Street, under the stairs leading to the South Bayfront Bridge. Emeryville currently has 12 stations.
- In 2025 the three Emeryville stations that were announced in 2023 will begin operating. All three stations have been approved by the City and encroachment permits have been submitted for their installation. The stations are anticipated to be operational in October. This will bring the total number of stations in Emeryville to 15.

CURRENT PRICING:

In 2023 pricing for an annual pass was \$169, with e-bike per minute usage costing 20 cents. As part of the previously discussed expansion agreement between Lyft and MTC, these prices were dropped. <u>Current pricing is</u>:

- \$3.99 for a single ride (up to 30 minutes)
- \$0.30 per minute additional cost for e-bikes
- \$15.00 for a day pass (unlimited 30 minute rides on a "classic" bike/not an e-bike)
- \$29.00 for a monthly pass (unlimited 45 minute rides on a "classic" bike/not an e-bike and \$0.15 additional cost for e-bikes)
- \$150.00 for an annual Bay Wheel membership (unlimited 45 minute rides on a "classic" bike/not an e-bike and discounts on e-bike and \$0.15 additional cost for e-bikes)

Bay Wheels also offers reduced fares via the <u>Bikeshare For All</u> program. Bay Wheels offers "reduced-rate memberships to Bay Area residents who qualify for CalFresh,

SFMTA Lifeline Pass, or PG&E CARE. The first year is \$5, and then it's \$5/month after that. No annual commitment required." Current benefits include:

- Unlimited free 60-min classic rides (\$0.13/min after that)
- \$0.05/min ebike rides (Max payment \$1)

CURRENT RIDERSHIP:

- Overall system memberships have increased by nearly 1,000 in the first year since prices were reduced and additional e-bikes were added (November 2023 – November 2024). Total systemwide membership exceeded 3,700 during this period.
- There are 1,747 active Bikeshare For All memberships.
- Ridership is growing at about 30% year over year.
- Last year there were about 2 million total rides. This year is on target for over 2.6 million.
- Single rides have increased by 6%
- Member rides have increased by 40%

PROGRAM COST:

Per the agreement between MTC and Lyft, there are no direct program cost to the City. Staff time towards bikeshare includes permitting for station installation (Lyft pays all permit fees), and two one-hour regional meetings a month in which local jurisdictions meet with MTC program operators for coordination, program updates, and to share resources.

The system saw financial improvements in 2024: a 23% increase in revenue and 1% reduction in operational cost despite an increase in system use. The decrease in operational cost is due to the addition of second generation e-bikes, which can go twice as far on a single charge and require less frequent replacement of parts than other bikes in the system. Despite this, the system still experiences about \$8 million in system loss annually.

Interstate 80 Powell St Transit Access Improvement Project






PROJECT DESCRIPTION

The Interstate 80 (I-80)/Powell Street interchange currently services multiple transbay bus routes, including Alameda Contra Costa County Transit (AC Transit) lines and the Capital Corridor (Amtrak) connecting bus between the Emeryville Station and San Francisco. The existing route on West Frontage Road and I-80 Powell Street loop on-ramp are highly congested during morning peak commuting hours. The Metropolitan Transportation Commission (MTC) and the Alameda County Transportation Commission (Alameda CTC) are proposing interchange improvements to address transit operational deficiencies that currently result in travel delays and decreased reliability for transit vehicles entering and exiting I-80 through Powell Street.

The I-80/Powell Street Transit Access Improvement Project includes the construction of a dedicated transit lane on Powell Street, new bus stops with improved pedestrian and bicycle access, and dedicated transit-only signals and detectors at the ramp intersections. The Project seeks to improve transit reliability and travel time, improve transit accessibility, promote safety for transit riders, and encourage transit use.
