Subject: Item 5.1 – Green Curb Approvals at Park Frontages Citywide

BACKGROUND:

The Public Works Department proposes the installation of two-hour time-limited parking zones (green curbs) on portions of streets directly fronting certain City parks. The specific green curb approvals would be at Christie Avenue Park and Doyle-Hollis Park. This proposal is a supplement to the recently approved parking restrictions for tall vehicles at park frontages.

On November 4, 2025, the City Council adopted Resolution No. 25-103, consenting to the Transportation and Sustainability Committee's designation of parking restrictions for oversized vehicles near City parks. To align with the California Vehicle Code and existing municipal authority, this action was specifically implemented through Emeryville Municipal Code section 4-9.32. This section authorizes the prohibition of parking for vehicles six feet or taller but limits the restriction to the first 100 feet of a street approaching an intersection. While this action addressed critical safety concerns at park entrances and corners, the 100-foot limitation leaves mid-block sections of some park frontages unregulated by the new restrictions. The installation of time-limited parking in these gaps is necessary to ensure consistent management along the entirety of park frontages and achieve the City's original safety and accessibility goals.

DISCUSSION:

Time-Limited Parking Zones

Per the Emeryville Municipal Code (EMC), the Transportation Committee is authorized to designate limited duration ("time-limited") parking zones. The EMC 4-9.17(d) identifies this authority as follows:

(1) The Transportation Committee is authorized to designate any street or publicly controlled off-street parking facility or any portion of any street or publicly controlled off-street parking facility as a limited duration parking zone. The Department of Public Works shall mark the curbs of limited duration parking zones green.

- (2) Upon designating a limited duration parking zone, the Transportation Committee shall recommend the appropriate duration of parking time to be allowed at the designated location. This time limit shall be included on signage and/or markings posted to alert the public that parking is permitted in that location for a limited time only.
- (3) It shall be unlawful for an operator to park any vehicle in a limited duration parking zone for a period in excess of the posted time limit.
- (4) Upon receipt of an application from a property owner adjacent to any City street for a limited duration parking zone, or upon the decision of the Public Works Director that a limited duration parking zone should be located on a City street or in a publicly controlled off-street parking facility, Public Works Department shall post a notice at the proposed location of the limited duration parking zone and within three hundred feet (300') of the proposed location for three (3) business days prior to the Transportation Committee and/or City Council meeting at which the request will be considered.

Staff recommends setting the time limits of the parking zones to match other two-hour time-limited parking zones (green curbs) nearby City Parks, which are limited to **6:00 AM** to **10:00 PM**.

RECOMMENDATION:

Staff recommend for the Transportation and Sustainability Committee members to review the attached Exhibit A and make a motion to approve the new curb zones.




Exhibit A - Map of Proposed Parking Restrictions on Streets Near City Parks (Green Zones)

Convert one hundred forty-five feet (145') of curb between existing red curb and curb extension on the northbound side of Christie Avenue and seventy-two feet (72') of curb between existing red curb and driveway on the southbound side of Christie Avenue to green curb (two hour parking).




Notice of Curb Color Change

Convert two hundred forty-five feet (245') of curb on the westbound side of 61st Street between points 100 feet away from the crosswalks at Hollis and Doyle Streets and two hundred twenty-one feet total (221') of curb on the eastbound side of 61st Street between points 100 feet away from the crosswalks at Hollis and Doyle Streets, excluding the existing yellow zone, into green zone timed parking (two hour parking).




