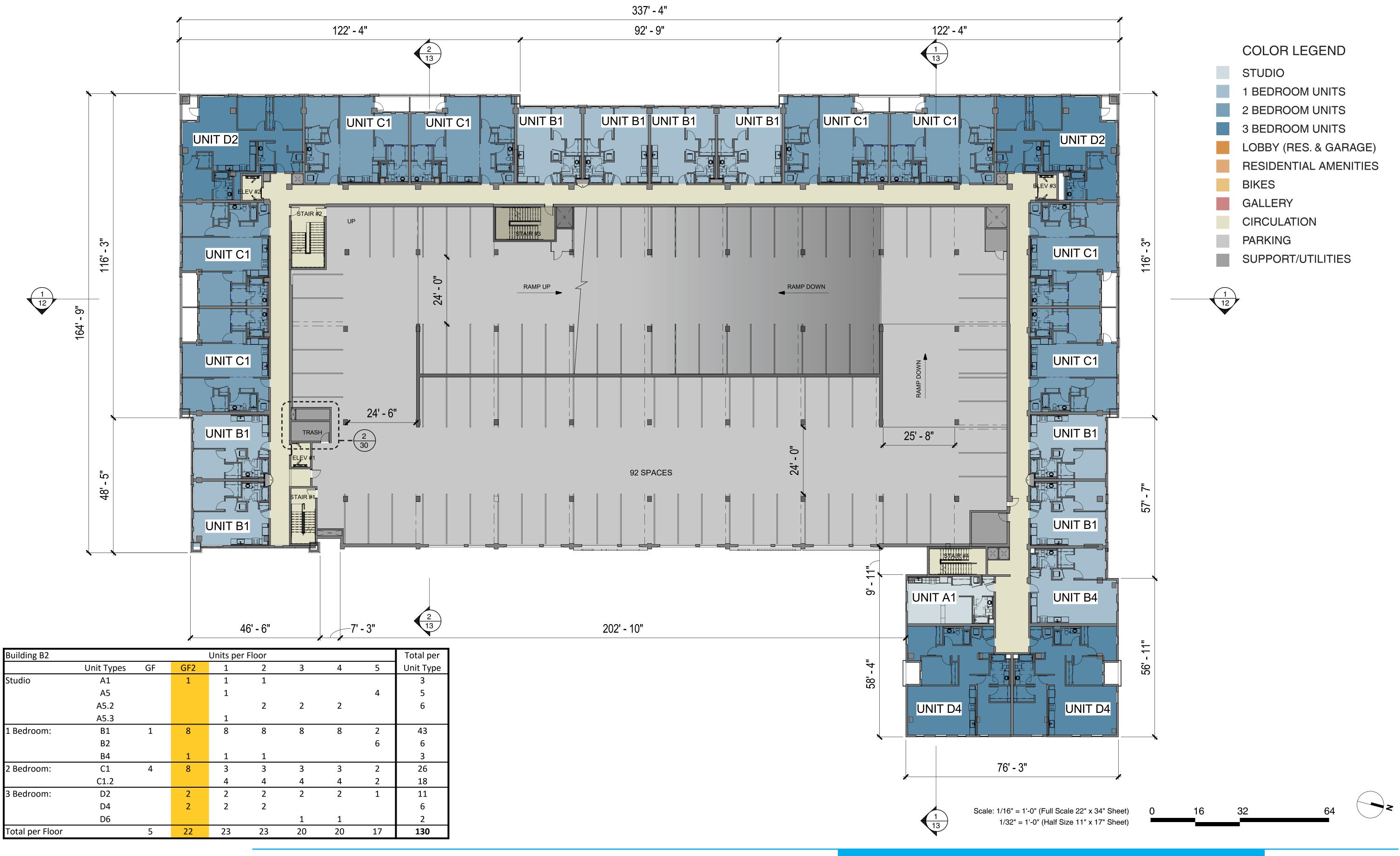




Site Plan & Ground Floor 1

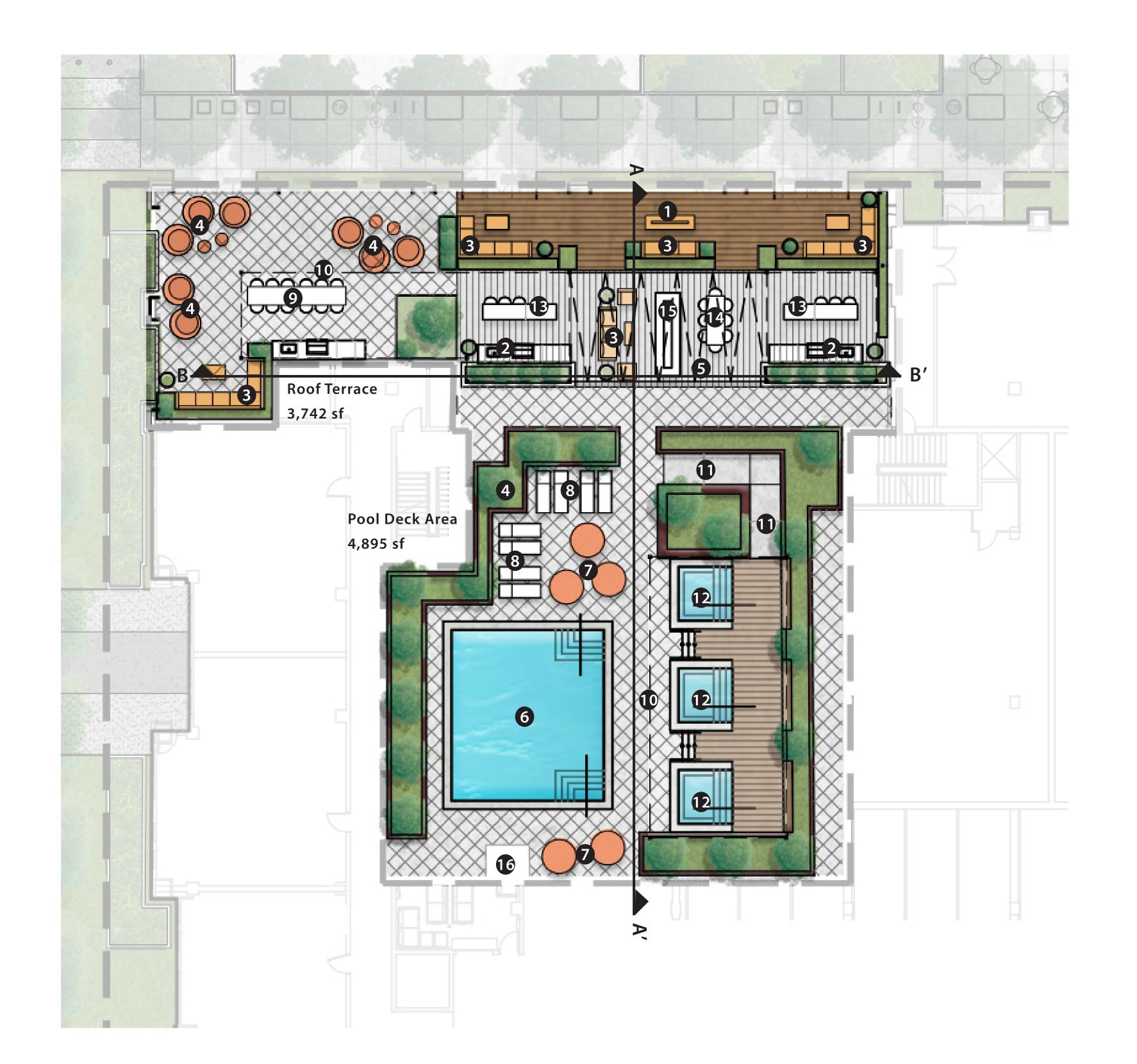


BUILDING B2: LANDSCAPE PLAN

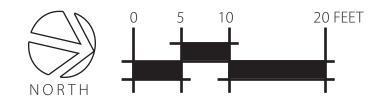

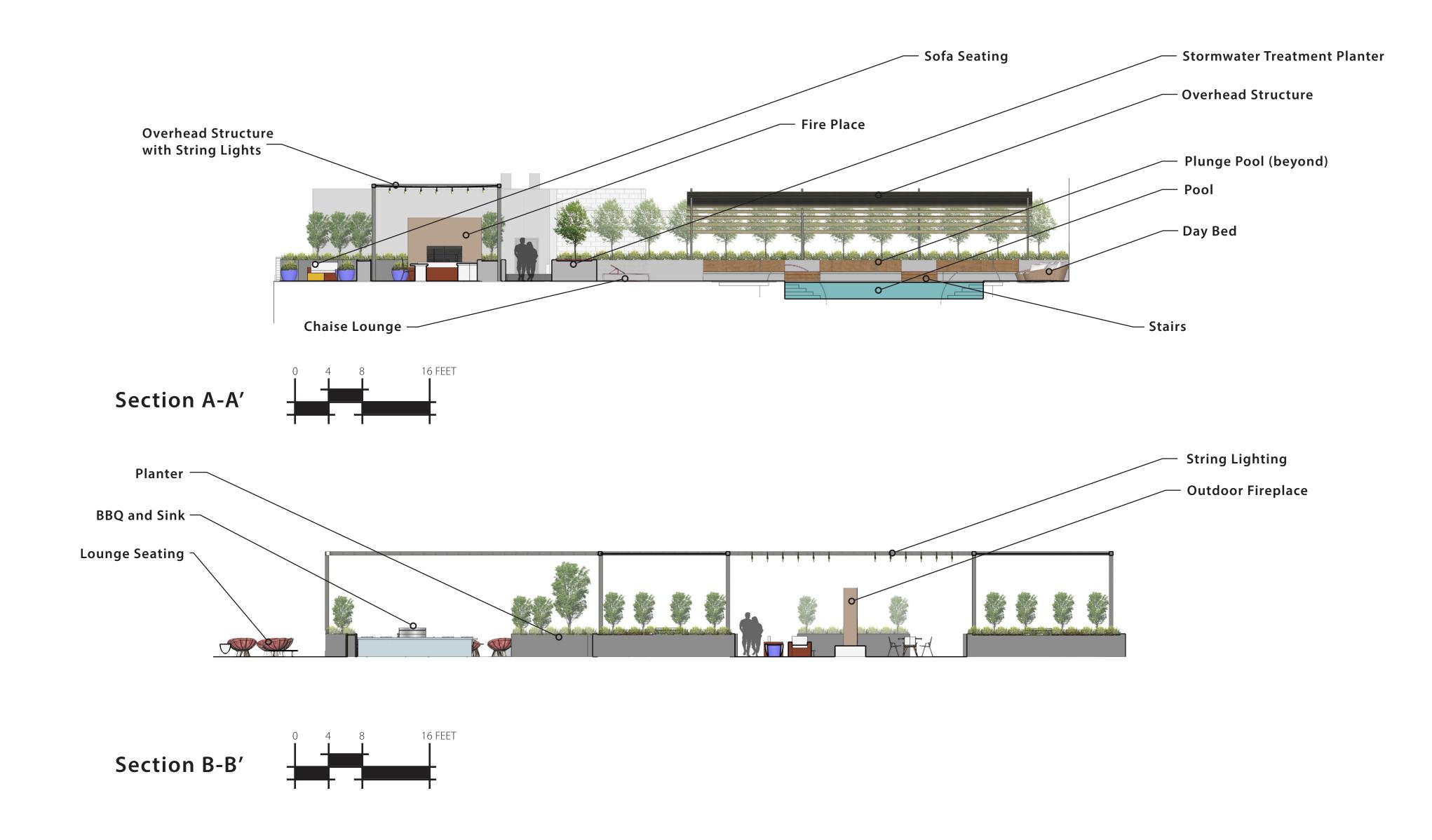


BUILDING B2: LANDSCAPE PLAN

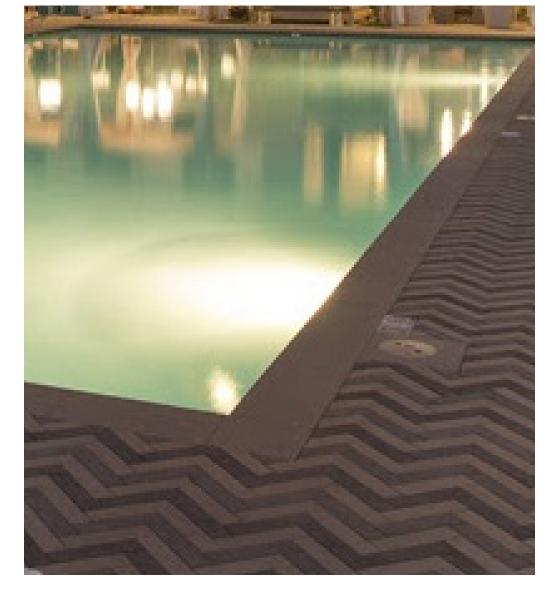
