

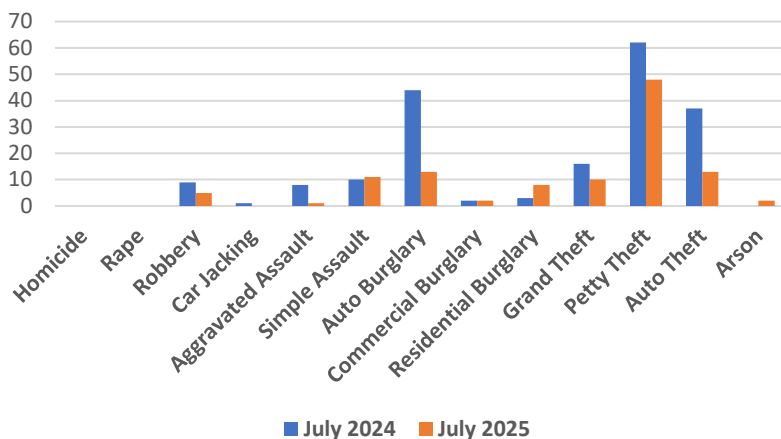

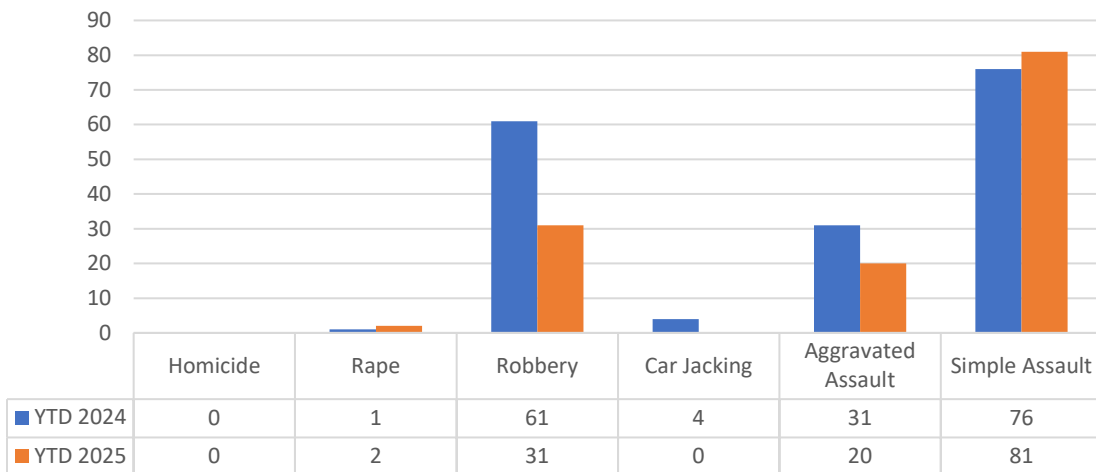

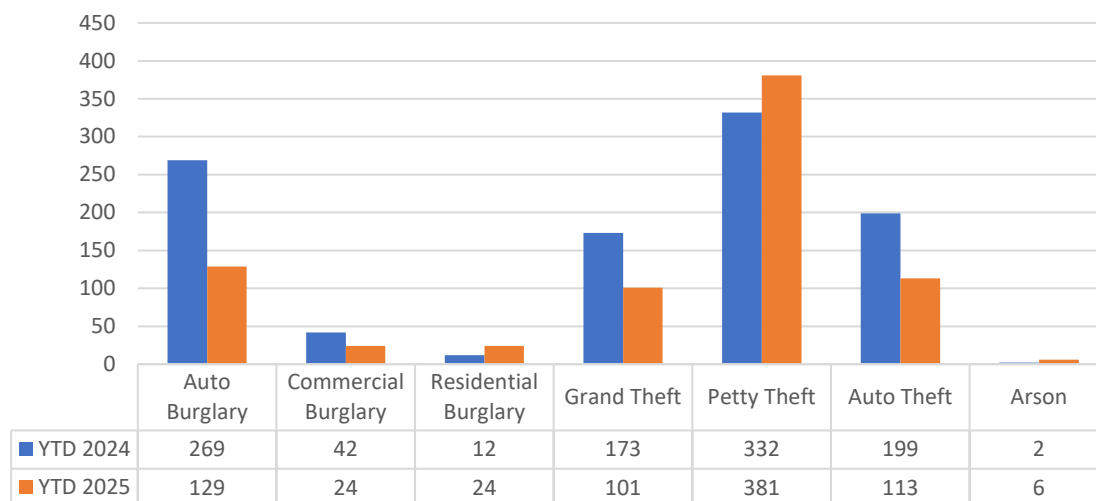

Violent Crimes Year to Date Comparison



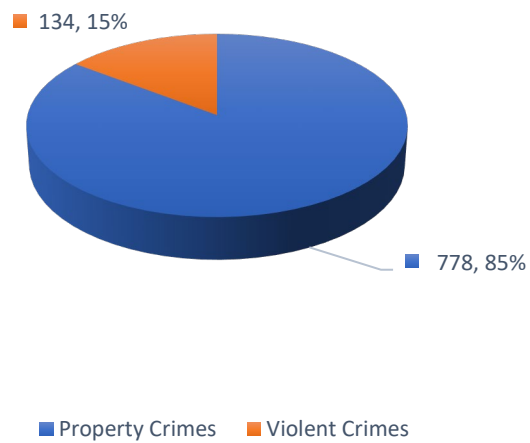
Property Crimes Year to Date Comparison



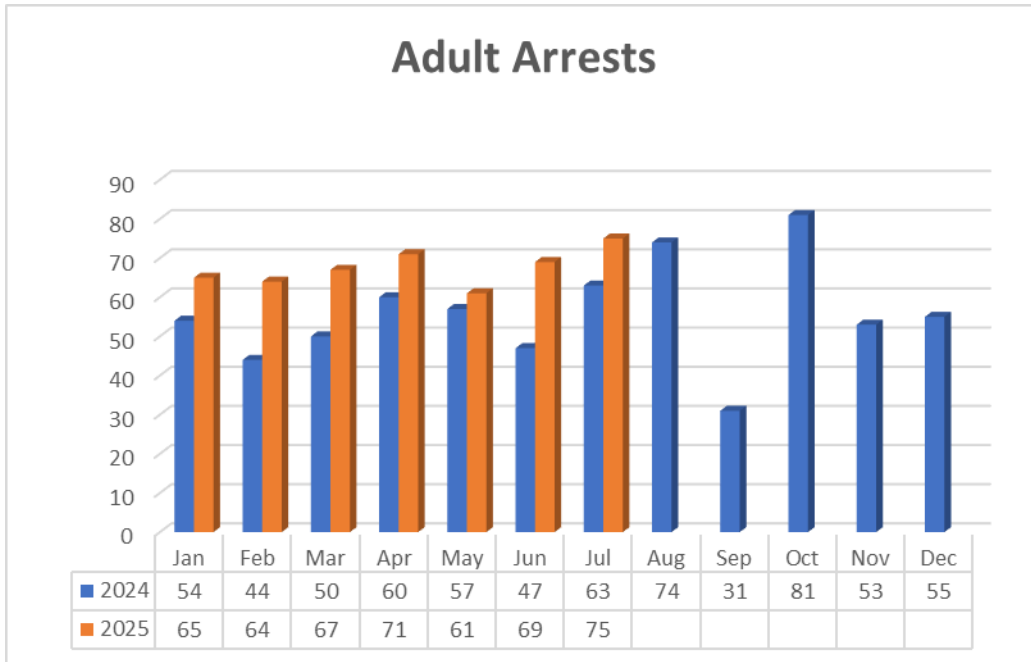

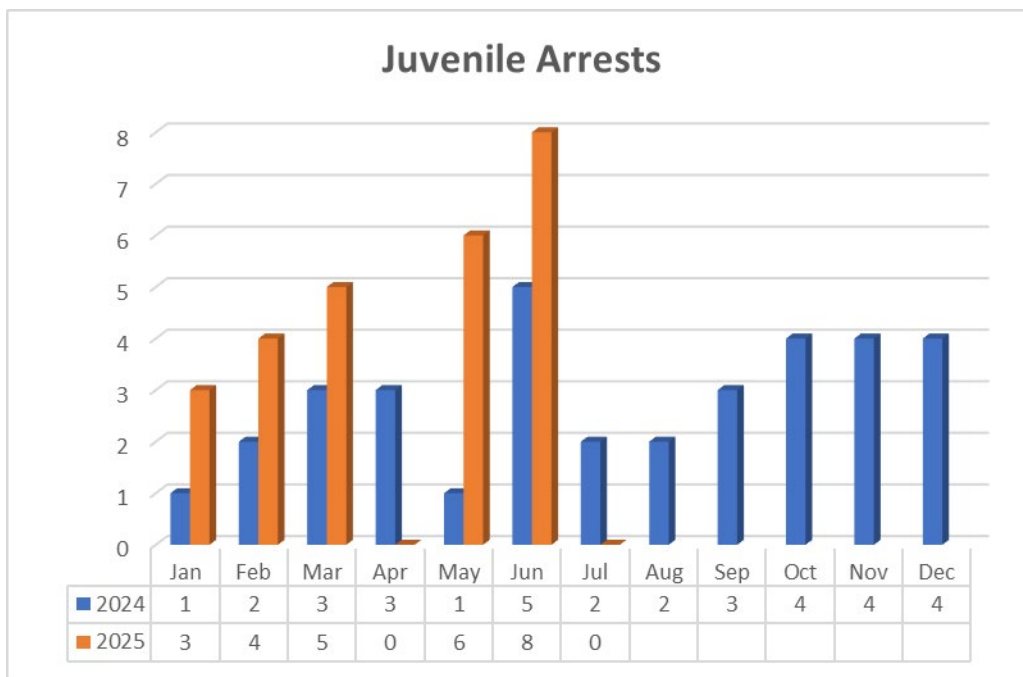
Year-to-Date Property & Violent Crimes

HIGHLIGHTS

2507-0172, 7/21/2025 at 0059 hours, Beat 1, Auto Burglary, 63rd/Market Dr., a citizen witnessed subjects breaking into a Direct TV Chevy Van parked at the listed location. The subjects fled in a black Honda. Officers located the Honda traveling south on San Pablo Ave. The Honda fled from officers and the officers elected not to pursue the Honda. An officer documented the incident on a crime report.

2507-0173, 7/22/2025 at 0442 hours, Beat 3, Residential Burglary, 10XX 45th St., a citizen reported hearing a loud noise coming from the front of the apartment and found a male subject wearing a reflective jacket breaking into the mailboxes. The subject fled the scene on foot westbound on 45th St. Officers could not locate the subject. It has been determined the subject is responsible for other reports of mailboxes broken into around the city.

2507-0186, 7/23/2025 at 0625 hours, Beat 3, Arson, W. MacArthur Blvd/Adeline St., a citizen reported a vehicle fire at the listed location. Officers arrived on scene and found an unoccupied Acura on fire. The Alameda County Fire Department responded and extinguished the fire. Officers located surveillance footage showing the suspect igniting the front end of the Acura and fleeing southbound on Adeline Street on a bicycle towing an orange cart. The suspect also attempted to set fire to a Honda parked in front of the Acura but was unsuccessful and fled the scene. Officers canvassed the area but were unable to locate the suspect.

2507-0204, 7/24/2025 at 1658 hours, Beat 1, Robbery, BevMo, 5717 Christie Ave., two male suspects entered the store and took numerous bottles of unpaid alcohol. One of the suspects used one of the bottles to hit the clerk on the head during the commission of the crime. The suspects fled on foot and were last seen fleeing in a silver Hyundai. The clerk refused medical, and a robbery report was taken.
