- 5.2 Public Art Committee (PAC) modify Neighborhood Convergence to improve pedestrian visibility and lower impacts on the artwork:
 - Leave four sculptures, those closest to the existing and proposed path, in their existing locations, protected on-site during construction
 - Extract, and store on City property, four works to be moved north or south to be visible on their front facing side from the path, unobscured by fencing, reinstalled in the final project between the relocated fencing and the path
 - Relocate the proposed path on the north side closer to the curb, to allow for lower costs and reduced impacts to the art project and greater visibility of the art by pedestrians
 - Add few elements to the fence such as painting adjacent to the painter, trees among the people or directional signage to the Marina and accessory elements inside the fence.
